

Zika virus infection weekly report

29 June 2016

This report summarises confirmed and probable Zika virus infection notifications for the previous week (22–28 June 2016) and cumulative cases for 2016. Cases that were still under investigation are not included. The case classification used in this report is specified on the last page.

The report incorporates the distribution of cases by sex, age and country(ies) travelled to during the incubation period for the disease. No further details on individual cases will be released.

Data in this weekly update is based on data recorded on EpiSurv by public health service staff as at 1020 hours 29 June 2016. Changes made to EpiSurv data after this date will not be reflected in this report. The numbers presented may be further updated and should be regarded as provisional.



Case classification for arboviral disease notification in New Zealand

Confirmed	A clinically compatible illness that is laboratory confirmed. Laboratory confirmation requires at least one of the following: <ul style="list-style-type: none">• isolation of the virus• detection of arbovirus nucleic acid• detection of arbovirus-specific IgM• IgG seroconversion• a significant increase (four-fold or greater) in antibody titres to specific arbovirus.
Probable	A clinically compatible illness in a person who has come from an endemic area.
Under investigation	A case that has been notified, but information is not yet available to classify it as probable or confirmed.
